


## Election of Club Officers

It's that time of year again, we will be voting for Club Officer the last dance of February. The Nomination Committee has been formed. Contact Jay Templin, Sherry Foreman or Jeannie Taylor for one of the following positions.

**President**  
**Vice-President**

The Committee would like to have at least 2 volunteers for each position. Nominations will also be taken from the floor.

The duties of the officers shall be as follows:

**PRESIDENT-** Presides at Club and Board meetings; appoints and removes appointed Board members and committees with the approval of the Board elected officers; may vote at club elections and meetings according to Robert's Rules or Order Newly Revised, Tenth Edition; acts in the best interest of the Club in the case of emergencies; calls Board and general membership meetings as required.

**VICE-PRESIDENT-**Assumes the duties of the President in his/her absence; is chair of the visitation committee; acts as parliamentarian including ensuring a copy of Robert's Rules of Order Newly Revised, Tenth Edition, is present at each meeting.

**RECORDING SECRETARY-** Takes minutes at all business meetings of the Club and Board and makes them available to all members upon reasonable request; maintains a complete and accurate record of the Club's By-Laws and subsequent changes.

**CORRESPONDING SECRETARY-** Maintains the Club membership roster and submits and publishes it as required by the Board. Prepares club correspondence as directed by the President.

**TREASURER-** Custodian of all Club funds; collects all monies; pays all bills with Board authorization; prepares financial reports for Board meetings and makes them available to the membership upon reasonable request; prepares a written financial report at the end of each dance season; submits all records for audit when a new treasurer takes office and at least once every two years if there is no change of treasurers.

**ASSISTANT TREASURER-** Assists the Treasurer as necessary and assumes the duties of Treasurer, including payment of bills, in the Treasurer's absence.

All elected officers shall be entitled to vote at Board Meetings.
